



#### State Medicaid: Historical Context

- Federal Law: Medicaid Inmate Exclusion Policy (1965)
  - Prohibits Medicaid from paying for any services while individuals are incarcerated, except for inpatient hospitals stays
  - Incarcerated individuals may be enrolled in Medicaid
- County and State facilities have improved strategies relative to Medicaid
  - States moving from "termination" to "suspension" of benefits
  - More individuals are enrolled in health coverage
  - More individuals are connected to care and services upon release
- Barriers remain, which can lead to delays and disruptions in care



#### Incarceration Rates

- Approximately 1.2M were incarcerated in federal or state prisons (end of 2020); approximately 549,100 were held in local jails (mid-2020)<sup>1,2</sup>
- Higher rates of mental illness and other chronic health conditions<sup>3</sup>
- Rates of substance use disorder (SUD) vary, range from 60% 90%<sup>4,5</sup>

States have sought to change the Medicaid Inmate Exclusion Policy (MIEP) through 1115 Waivers

Dear State Medicaid Director

The Centers for Medicare & Medicaid Services (CMS) is issuing the following guidance for designing demonstration projects under section 1115 of the Social Security Act (the Act) (42 U.S.C. § 1315) to improve care transitions for certain individuals who are soon-to-be former immates of a public institution (hereinafter referred to as incarcerated individuals, except when quoting from statute) and who are otherwise eligible for Medicaid. This letter also provides guidance to interested states about development and submission of the associated section 1115 demonstration aspulcation.


This guidance continues to implement section 5032 of the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities Act (SUPPORT Act) (Pub. L. No. 115-271), Promoting State Innovations to Ease Transitions Integration to the Community for Certain Individuals. As mandated in section 5032, the Department of Health and Human Services (HHS) convened a stakeholder group to develop best practices for states to ease health care-related transitions for incarcerated individuals to the community and to develop a Report to Congress (RTC) On December 1, 2022, HHS transmitted the RTC to Congress. Additionally, section 5032 directs the Secretary of HHS, through the Administrator of CMS, to issue this State Medicaid Director Letter (SMDL) regarding opportunities to design demonstration projects under section 1115 of the Act to improve care transitions for incarcerated individuals exiting a public institution and who are otherwise eligible for Medicaid, and to base this guidance on best practices identified in the RTC.

As provided in section 1115 of the Act, the Secretary of HHS may waive certain provisions of section 1902 of the Act and/or provide authority for federal matching of expenditures that otherwise would not be eligible for federal financial participation (FFP) under section 1903 of the Act, where the Secretary determines that the demonstration project is likely to assist in promotting the objectives of Medicaid. While CMS reviews every section 1115 demonstration

# Section 1115 Reentry Demonstration Opportunity (cont.)

#### Per the Guidance:

- Application submitted by states.
- State prisons, county jails, and juvenile justice facilities are eligible.
- Required services:
  - Case management, medication-assisted treatment, and a 30-day supply of all prescription medications at release.
- Additional physical and behavioral services, including:
  - Peer supports, community health workers, family planning, additional treatments and medications, and other services.



#### Focus for Today

- States must reinvest Medicaid matching funds:
  - "Into initiatives that <u>increase</u> access to or <u>improve</u> the quality of health care services for "soon-to-be released" individuals or for recently released individuals."





