State by State COVID-19 Emergency Housing Information for Persons Reentering the Community in Needs of Safe Shelter and Housing

Introduction

More and more correctional facilities are releasing persons in order to reduce populations as a result of the threat posed by the COVID-19 pandemic. Many RSAT program participants are in this number. The fast-tracked release of so many persons at a time when many re-entry programs, social services, and transition housing resources may be temporarily closed or operating at limited capacity calls for the redoubling of reentry and transitional programming. Nothing may be of more critical importance than locating safe and secure housing for those being released who do not have secure housing waiting for them. This manual was designed to assist in that effort.

Since many transitional housing facilities have closed their doors or transferred residents to accommodations that allow for social distancing, isolation or quarantine, information on shelter closings and regional shelter coordination centers has become critical. The information on emergency housing resources and contacts for each state is based on the most current information available. However, because conditions are changing rapidly, it is important to verify that the services listed are still available. Contacts and information on COVID-19-specific state and local contacts listed include emergency and non-congregate housing options such as short-term hotel room leasing, converted dormitories or public buildings, and trailer units.

In cases where there is little or no information on COVID-19-specific housing resources, contacts for coalitions to end homelessness, local or state housing and homelessness continuums of care, and other reliable contacts for housing resources are included.

State resources follow immediately after federal and national resources are listed.

Note: Nearly all states have instituted a moratorium on evictions and have resources available for rent and mortgages relief programs.

Note: Several states have received permission from FEMA to use federal disaster funds to provide emergency housing. In all cases, FEMA guidance has indicated moving homeless individuals out of crowded congregate areas is an allowable use of funds.

State by State COVID-19 Emergency Housing Information

♦Alabama

Housing Resources: Homeless shelters throughout the state have reduced capacity or closed their doors altogether. The Salvation Army in Mobile has been forced to reduce the capacity at its homeless shelter to comply with COVID-19 distancing rules, while the Waterfront Mission, Wings of Life, McKemie Place (women's shelter) are not taking new clients. One Roof which serves Bessemer, Birmingham, Hoover/Jefferson, Shelby, St. Clair Counties has closed. However, Housing First, which serves Mobile and Baldwin Counties is open, but is limiting face-to-face meetings and coordinating entry intakes, referrals, and emergency information by phone (251) 450-3345. For statewide emergency housing information dial 311, or contact local County Health Departments and Department of Human Resource Offices.

Emergency Order: Non-Congregate Sheltering

♦Arizona

Housing Resources: Gov. Ducey's COVID-19 relief package includes \$6.7 million to support vulnerable Arizonans. The Emergency Crisis Contingency and Safety Net Fund is dedicating \$5 million toward assisting homeless shelters in preventing and slowing of the spread of COVID-19 through:

- Temporary isolation and quarantine housing;
- Sanitation supplies and services;
- And other direct resources as needed.

The Governor also has directed the Arizona Department of Housing (ADOH), the Arizona Department of Economic Security (DES), and the Arizona Department of Administration (ADOA) to join together to work with public and private-sector partners to help ensure the homeless have clean and safe housing.

<u>Phoenix</u>: On April 21, Phoenix City Council dedicated nearly \$27 million dollars of federal COVID-19 funding to support vulnerable populations in the community. The money will be used to combat homelessness, address housing insecurity, and provide micro-loans and grants for local small businesses and non-profits. ◆Alaska

The two facilities being used for emergency overnight shelter are the Sullivan Arena and Ben Boeke Ice Arena, which allows sufficient space for shelter officials to set up sleeping facilities at a distance of six feet apart.

♦ California

Housing Resources: Executive orders by Gov. Newson pertain to a moratorium on evictions, foreclosures, extending public housing application deadlines, and monitoring actions of utility companies. The state has budgeted \$50 million to helping to shelter its estimated homeless population of 150,000, statewide. It is estimated that from 20-30% of the incarcerated population may be homeless. So far, the state has procured at least 7,000 short-term hotel room leases to accommodate vulnerable populations and those experiencing homelessness, and is leasing trailer units. <u>Fresno</u>: City/county made 300 beds available; and have already filled 200. Approximately \$2 million in state funds, plus \$3 million in local funding will be used to house homeless and secure resources. City and county leaders are working with hotel and motel owners.

<u>Los Angeles:</u> The mayor announced the city will add 1,600 of emergency shelter beds in thirteen city recreation centers to help get homeless Angelenos indoors, using money from a \$20 million budget reserve fund in partnership with City Council. More locations to be identified. The city will work with the County, LAHSA, and other partners to identify individuals in the homeless population who face the greatest risk from the coronavirus for Los Angeles County-Project Roomkey: https://covid19.lacounty.gov/homelessness-and-housing/

<u>Sacramento</u>: Sacramento has approved a \$15-million joint city and county plan to provide nearly 1,000 beds for homeless people either diagnosed with or at high-risk for contracting COVID-19. These beds — located in motels, trailers, and existing shelters- will allow at-risk or infected homeless people to be cared for in isolation. The City's shelter on North Fifth Street was expanded. However, there is no walk-up admission to the trailers at Cal Expo or the hotels rooms that the County will be leasing. Referrals will

The joint plan is being implement by the Sacramento Homelessness COVID-19 Response Team task force, Sacramento Steps Forward, and the Sacramento Housing and Redevelopment Agency (SHRA). Elements of the plan include: 850 motel rooms and 63 new travel trailers at Cal Expo.

<u>San Diego</u>: Dubbed "Operation Shelter to Home," the temporary repurposing of the convention center as a shelter will support a broader regional approach to address homelessness during this state of emergency. The county's nine bridge homeless shelters with public nurses will convert to screening and triage centers. The county has secured 1,954 hotel rooms for people showing coronavirus symptoms or for vulnerable populations. Contact San Diego County directly for sheltering the homeless through the

San Francisco: Mayor Breed created a \$5 million emergency fund in response to COVID-19 and its potential impact on homeless people and residents of single-room occupancy hotels. Temporary isolation housing will include recreational vehicles (RVs), which have been leased and will be staged in the Presidio. The RVs will be placed in various secure locations throughout the city as needed. The City is also in the process of identifying additional locations for auxiliary quarantine housing, including unoccupied residential property. City officials have identified 8,000 possible rooms so far. <u>San Jose</u>: In collaboration with the Santa Clara Office of Supportive Housing, the City of San Jose Housing Department is supporting the local emergency effort to house those experiencing homelessness. Also available 24-hours, include limited case management and referrals.

FEMA approved NJ's request to fund emergency, non-congregate sheltering for individuals in need; therefore, state, county, and local entities can be reimbursed for costs of hotels or motels for certain vulnerable populations, including: homeless families who live in congregate shelters with at least one family member who has tested positive for COVID-19 and homeless individuals who require quarantine or isolation due to a positive test for COVID-19.
