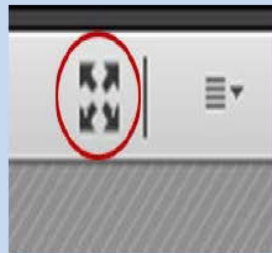





Addiction is a treatable, chronic, relapsing brain disorder.

- It is a medical disease involving complex interactions among brain circuits, genetics, the environment, and an individual's life experiences.
- People with addiction use substances or engage in behaviors that become compulsive and often continue despite harmful consequences.

According to the NSDUH 2018 Report, 1 in 7 young adults had a past year SUD and about 1 in 14 Americans age 12 and over had a past year SUD.

Drug overdose deaths in the United States rose 4.6% in 2019. (AHA.org)



The age-adjusted rate of overdose deaths in 2018 was nearly 21 Americans per 100,000. (CDC.gov)

Opioids are responsible for nearly 70% of overdose deaths. (CDC.gov)

Opioid Treatment: Which Path is Right?

- Opioids are one of the few substances that have medications to support recovery:
 - Methadone
 - Buprenorphine
 - Naltrexone
- There is no one right way.
- Programs should be able to offer all options, either in house or through strong referral base.

Distinguishing QUALITY Treatment

- **Dual Diagnosis Capable** – Substance Use Disorder (SUD) often co-occurs with other mental health disorders. See SAMHSA TIP42.
 - Prescriber availability
 - Integrated processes
 - Medical team participation
- **Individualized Treatment Planning**
 - Validated assessments
 - “I” statements
 - Life skills
 - Progressive stages
- **Family and Community Linkages**
 - Aftercare planning and connections
 - Positive support and participation
- **Peer Support**
 - Forensic
 - Substance Use
 - Mental Health
 - During & Post-treatment
- **Progress and Outcome Measurement**
 - Patient subjective experience
 - Data informs programming and treatment

The Connection:

Law Enforcement Deflection and Diversion Supporting Recovery Month

- Law Enforcement Deflection and Diversion connects people to treatment, MAT, housing, recovery, and services.
- Law Enforcement Deflection and Diversion is a team approach that helps people access MAT and promotes recovery.
- Of the five Pathways to Deflection and Diversion, the Naloxone Plus Pathway directly incorporates MAT as multiple required elements for deflection.
- The Naloxone Plus Pathway was built specifically and is ideally suited for responding to opioid overdose.

Naloxone Plus Deflection

COSSAP National Mentor Site: Colerain Township, OH

- In 2015, originated the Quick Response Team (QRT) Model, the most common form of Naloxone Plus Deflection
- Joint response model that involves community behavioral health, peer support specialists, EMS and law enforcement
- Involved local businesses and community members from the beginning
- Eventually turned into a county wide initiative that has been adopted widely in WV, KY, OH
- Incorporates MAT through treatment partners

Naloxone Plus Deflection

**COSSAP National Mentor Site:
Huntington, WV**

- Joint response model that involves community behavioral health, peer support specialists, EMS, and law enforcement
- Responses also include representatives from the faith community, an evolution of the original QRT/Naloxone Plus pathway
- Cross-agency communication was prioritized to address overdose data inconsistencies
- Incorporates MAT through treatment partners

Naloxone Plus Deflection

**COSSAP Grantee Site:
Onslow County, NC**

- Expanded the role of the Community Paramedics Program (CPP) to respond specifically to the growing opioid crisis, beyond high-utilizers
- After Naloxone Plus/QRT-type follow up by law enforcement, CPP provides individualized and active support for up to a year
- Peer specialists supplement CPP efforts, in addition to social workers
- Two grant initiatives will enable CPP to directly administer FDA-approved MAT in the field
- CPP's attend CIT training alongside law enforcement

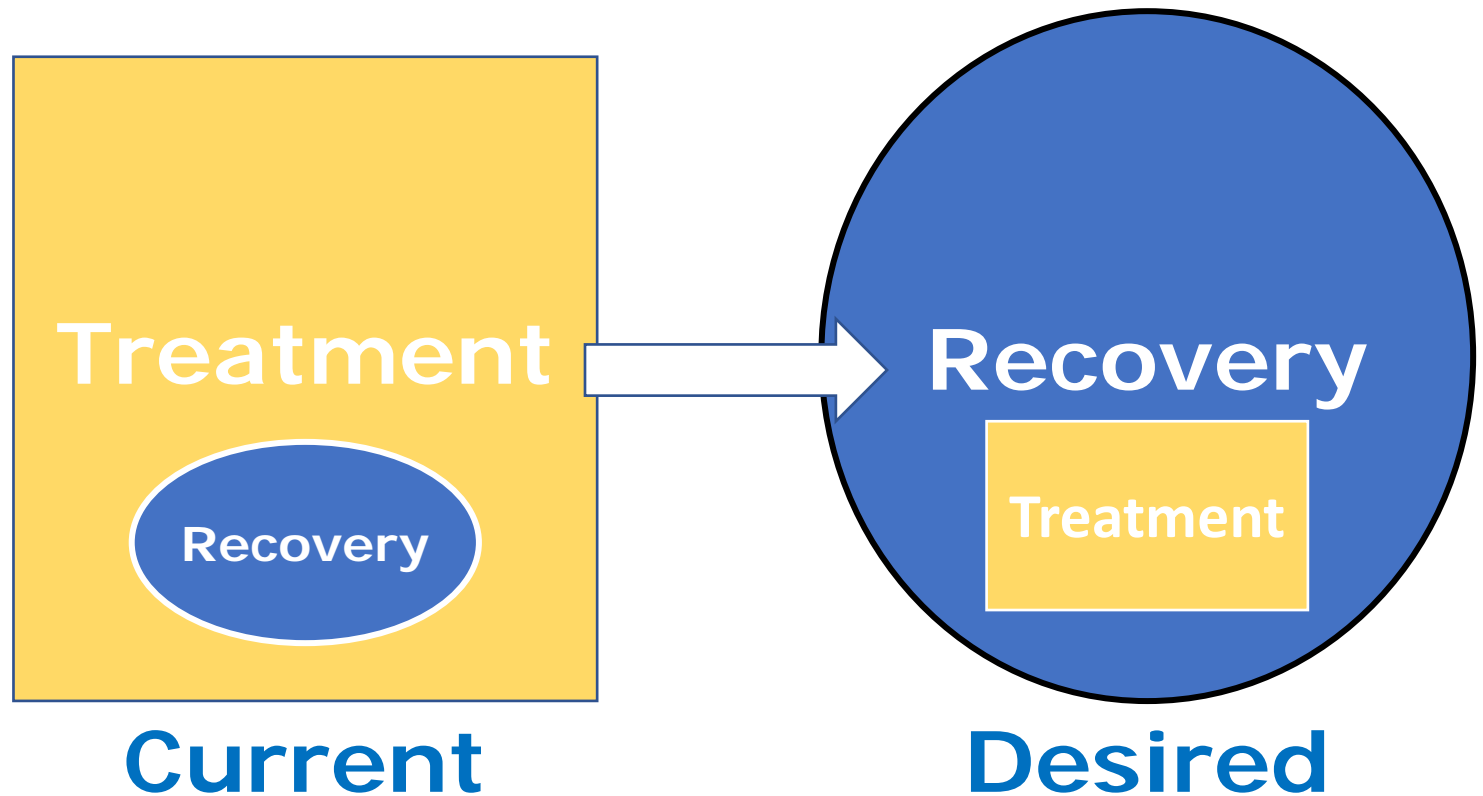
